"Election Systems and Software [ES&S]: The largest seller of computerized voting systems in the country, ES&S counts Nebraska Senator Chuck Hagel (R) as its former top exec. ES&S is a subsidiary of the McCarthy Group, Inc., a merchant-banking company based in Omaha. It's headed by Michael McCarthy, who (coincidentally) serves as Hagel's campaign treasurer. The senator continues to hold some \$5 million worth of stock in the McCarthy Group - yes, the company that counts Hagel's votes in each of his elections!"

#### PRESS RELEASE

On Monday, October 24, 2016, at the beginning of Early Voting it was brought to the attention of the County Clerk, Heather H. Hawthorne, that the Straight Party vote for both the Republicans and Democrats, did not automatically select one race on each ballot. The error was caused in programming by ES&S Election Systems and Software Inc., the vendor who programs the election software used in Chambers County. Immediately, Hawthorne contacted ES&S and advised them of the issue. Hawthorne then contacted the Secretary of State's office, the office overseeing the elections in Texas, and was informed to create emergency paper ballots to be used until the problem could be fixed.

ES&S, based in Dallas, informed Hawthorne they would send software to correct the issue. Today, Hawthorne will be in the polling locations to install the corrected software to the electronic machines. Hawthorne is confident that all machines should be ready by the end of today.

Election Systems & Software was founded in 1979 as American Information Systems Inc. (AIS). It merged with Business Records Corp. the following year and changed its name to ES&S. It is now a subsidiary of McCarthy Group, LLC, and McCarthy Capital. As of 2007 it was the largest manufacturer of voting machines in the United States, claiming customers in 1,700 localities. As of 2007 it had approximately 350 employees; 2005 revenues were \$117 million. ES&S announced its purchase of AutoMARK Technical Systems on January 28, 2008.

According to OpenSecrets, the company who provided the alleged glitching voting machines is a subsidiary of The McCarthy Group.

The McCarthy group is a major donor to the Clinton Foundation - apparently donating 200,000 dollars in 2007 - when it was the largest owner of United States voting machines. Or perhaps the 200,000 dollars went to paying Bill Clinton for speeches?

Either way, it doesn't look good.

But there's more.

As the same user notes [in this post](#), Dominion Voting Systems and The Clinton Foundation did a 2.25 million dollar charity initiative in developing nations together called the DELIAN Project.

According to the project's [own website](#):

In 2014, Dominion Voting committed to providing emerging and post-conflict democracies with access to voting technology through its philanthropic support to the DELIAN Project, as many emerging democracies suffer from post-electoral violence due to the delay in the publishing of election results. Over the next three years, Dominion Voting will support election technology pilots with donated Automated Voting Machines (AVM), providing an improved electoral process, and therefore safer elections. As a large number of election staff are women, there will be an emphasis on training women, who will be the first to benefit from the skills transfer training and use of AVMs. It is estimated that 100 women will directly benefit from election technology skills training per pilot election.

Of course, this is all speculation, and we are not making any claims of illegal activity by the Clinton Foundation.



However, it presents a very troubling conflict of interest. Most Americans would certainly agree that voting machines should have zero connection to presidential candidates and their foundations.

Consider the implications further abroad, as well. Could this DELIAN Project be designed to influence elections in developing nations?

It can certainly be argued that electronic voting machines do not in fact provide an "improved electoral process" or provide "safer elections"

*Again, this is speculation.*

*But we will be keeping an eye on this story if and when more information becomes available.*
